The request is for \$100,000/year for 3 years — with ten \$10,000 awards each year across the cities in the county for businesses to apply for a grant to improve the façade of their building. Pros and cons were shared for a CDBG grant option that could be utilized for this type of program.

gineer Ridenour gave department update and expressed interest in knowing what the cities in Allamakee County are using their American Rescue Plan dollars for. January 27 is next 6-county meeting for Engineers and Supervisors in Fredericksburg. Auditor Beyer gave department update and reminder that county offices are closed Friday, December 31, 2021 in observance of New Year's Day.
