Meeting called to order by Schellhammer, followed by Pledge of Allegiance.

22.050-Motion Reiser/Second Byrnes to approve today's agenda and minutes from January 31 and February 2, 2022 meeting. Motion carried.

Public Comment: None

Dr. David Schwartz spoke to Supervisors about Medical Examiner charges for services, and also transportation for autopsies and psychiatric patients, to bring these issues to the forefront of the minds of the involved parties for future planning. The ME position is an independent position from the hospital. Dr. Schwartz has chosen not to bill the county for Medical Examiner calls but notes that any future ME will want to be paid. It will need to be determined how future Medical Examiners will bill the county for services and the county needs to plan for those expenses. Transportation of bodies to the State Medical Examiner in Ankeny was discussed, as well as transportation of mental health/psychiatric patients to facilities around the state, if they are healthy enough to not have to go by ambulance. Purchase of a vehicle for either purpose or both was suggested by Schwartz.
