lowa Code Section 49.31 requires that candidates' names be rotated among all precincts for races where there are more candidates than the "vote for" number. Therefore, the order of candidates may be different depending on precinct

ID: All voters are required to provide an approved form of identification at the polling place before they may receive and cast a regular ballot. Any voter unable to show approved ID may have their identity attested to by another registered voter in the same precinct who has proper ID and vote a regular ballot, or may vote a Provisional ballot and provide ID to the County Auditor by Monday, June 13 at Noon to have their ballot counted. Voters who are not pre-registered or who have changed precincts may be required to also provide proof of residence. ABSENTEE VOTING: In person absentee voting is available at the Allamakee County Auditor's Office May 18th at 8:00a.m. thru 4:00 p.m. on Monday, June 6, 2022. Regular office hours are Monday through Friday, 8:00 a.m. to 4:00 p.m. The Auditor's Office will also be open for absentee voting on Saturday, June 4, 2022 from 8:00 a.m. to 4:00 p.m. County offices are closed on Monday, May 30 in observance of Memorial Day. Mailed absentee ballots must be received by Auditor no later than 8:00pm on Election Day to be counted.

The deadline to request an absentee ballot by mail was Monday, May 23, 2022.

PRE-REGISTRATION DEADLINE is May 23, 2022 to be included in the voter registry on Election Day. If not pre-registered, eligible persons have the right to register to vote and cast a ballot on Election Day, if they are able to provide proof of both their identity and residence at the polls. Please bring a valid and current photo ID which has an expiration date. If the address on your ID is not current, you will need to prove residence with a document that contains your name and current address. If you do not have proof of residence and identity, a registered voter in your precinct may attest for you. You will both be required to sign an oath. Any questions regarding this matter should be directed to the Allamakee County Auditor's Office at (563) 568-3522.

ACCESSIBILITY: All polling places designated for use in this election are accessible to persons with disabilities. Any voter who is physically unable to enter a polling place has the right to vote curbside, in the voter's vehicle.

PUBLIC TEST: The general public is invited to a Public Test of the Unisyn Voting System to show how the votes will be counted for the Primary Election. The demonstration will begin at 9:00 a.m. on Thursday, June 2, 2022, on the 4th floor of the Allamakee County Courthouse, 110 Allamakee St, Waukon, IA.
