MINUTES OF THE ALLAMAKEE COUNTY BOARD OF SUPERVISORS MONDAY,

JULY 18, 2022 (UNOFFICIAL) Board members present: Byrnes, Reiser and Schellhammer. All members voting "AYE" unless noted.

Meeting called to order by Schellhammer, followed by the Pledge of Allegiance.

22.261-Motion Byrnes/Second Reiser to approve today's agenda and minutes from July 11, 2022. Motion carried.

The following people were present at various times throughout the meeting in person: Lissa Blake – Waukon Standard, Denise Beyer – Auditor and Clerk to Supervisors, Dave Monserud, Heather Bente, Sandy Lloyd, Detra Dettmann and Bruce Blair with DNR, Dennis Blocker, Val Reinke, Clark Mellick. Public Comment: Detra Dettmann

and Bruce Blair with DNR were present to address some things about the Yellow River State Forest. Their interpretation from their bureau of the new legislation is that ATVs are allowed to go through YRSF on through-roads, but not allowed on roads contained within the YRSF, such as through campgrounds. The campgrounds are the state "park" portion of the State Forest. Sandy Lloyd commented her for case preparation. Attorney Gericke does not see this affecting Kistler's time with Allamakee. No action taken until paperwork is received from Fayette County.

Supervisor Schellhammer explained that Winneshiek Energy District is working with Lansing as the pending closure of the Lansing power plant approaches. They are seeking a letter of support from Supervisors regarding the Empowering Allamakee County application for funding via the USDAs Rural Energy Pilot Program (REPP).

22.265-Motion Reiser/Second Byrnes to sign the letter of support for the Empowering Allamakee County application. Motion carried. Jon Luchsinger provided informa-

tion regarding replacing the Meeting Owl in the Board room. Supervisors are in agreement to pay the insurance deductible and replace the Owl until new Audio/Visual equipment is installed and then the Owl can be used in another meeting room.

Department Head updates: Sheriff Mellick has received a map of the roads that ATVs are allowed on in YRSF, provided by DNR. Sheriff Mellick also commented that he would like to see children restrained and wearing helmets on ATV and UTV vehicles for safety, regardless

that signage is already up at the campsites. Val Reinke gave event update including the Star City Film Festival and Lansing and Waukon RAGBRAI meetings.

Heather Bente, Čity Clerk and Librarian, reviewed Waterville events and library events, and thanked the Supervisors for their support of the libraries. Dave Monserud, Mayor, gave a report on the School Community Center building and events held there, grants and a new building going up downtown.

Auditor Beyer gave balances in the Partially Self Funded checking account and money market accounts and requested permission to move funds from the checking to the interest earning money market. 22.262-Motion Byrnes/Second Reiser to approve Auditor Beyer moving \$200,000.00 from WSB Checking to Freedom Money Market account. Motion carried.

22.263-Motion Reiser/Second Byrnes to accept and place on file the MMP update for Chestnut Farm Site 2. Motion carried.

Attorney Gericke recommended setting a public hearing to repeal the ATV/UTV Ordinance.

22.264-Motion Reiser/Second Byrnes to set August 1 at 9:40 for public hearing for repealing ATV/ UTV Ordinance. Motion carried.

Attorney Gericke has been contacted by Fayette County Attorney's office to help with their juvenile court caseload. Fayette County Attorney is retiring and their assistant is taking a different job. Jill Kistler has agreed to temporarily fill in for Fayette juvenile cases. Fayette County will compensate Kistler for her mileage and duties, starting August 8, at 10 hours/week on average and provide office space for of the new legislation not requiring it. Auditor Beyer commented that she will be working on preparing tax statements over the next couple weeks.

Engineer Ridenour presented bids for repair of English Bench watershed Site 9. Nine contractors took out plans and proposals with just one bid being received. The bid bond envelope is unsealed and empty. Bids are not allowed to be opened unless the bid bond is included, so this bid remained unopened. Ridenour recommends talking to County Attorney on how to proceed. No late bids will be allowed by other contractors.

22.266-Motion Byrnes/Second Reiser to table the opening of bids until next week. Motion carried.

Quotes for LP were reviewed: Ag-Vantage FS - \$1.65/gallon; Consolidated Energy - \$1.74/gallon; Waukon Feed Ranch - \$1.699/ gallon; Welch, Inc. - \$1.74/gallon. Engineer Ridenour recommends accepting low bid from Ag-Vantage FS.

22.267-Motion Reiser/Second Byrnes to accept bid from Ag-Vantage FS at \$1.65/gallon for FY23. Motion carried.

22.268-Motion Byrnes/Second Reiser to set letting date of August 8 at 10:00am for concrete pavement patching. Motion carried.

Ridenour gave department and project updates.
