MINUTES OF THE ALLAMAKEE COUNTY BOARD OF SUPERVISORS MONDAY, JULY 21, 2025 (UNOFFICIAL)

Board members present: Byrnes, Keatley and Clark. All members voting "AYE" unless noted.
Meeting called to order by Byrnes, followed by Pledge of Allegiance.
25.253-Motion Keatley/Second Clark to approve today's agenda and minutes from July 14, 2025 meeting. Motion carried.

The following people were present at various times throughout the meeting in person and/or by zoom: Joseph Moses – Waukon Standard, Denise Beyer – Auditor, Patty Olson, Deb Stantic, George Blair, Brian Ridenour, Val Reinke.

Public Comment: Val Reinke reported on the County Fair, a meeting with legislators and others related to the closure/tearing down of Lansing Black Hawk bridge, and other events. Byrnes thanked the Fair Board for all their work on a successful fair.

Patty Olson, New Albin library director, gave a library update on programs including a new Lego Club, and new puzzles and games for checkout; open 22 hours/week; thanked Supervisors for the county's continued support.

Deb Stantic, City Clerk, gave city updates: preparing for state audit and closing out fiscal year; completed Algaewheel wastewater plant project for which New Albin won an All Star Community Award; new water well project; resurfacing splash pad next year. NAIL does a lot of fundraising for the upkeep and the City provides the water for the splash pad. George Blair provided more information on potential for a solar array to power the Algaewheel plant; solar array would be similar to the size at the County Sheriff's office: the land is just over the state line into Houston County and he needs to obtain a permit from Houston County; city received a \$600,000 loan forgiveness for the new City well, along

with a \$400,000 grant.

NAIL has a 5K race coming up to help children with school supplies and they also help with maintenance expenses for the splash pad. Keatley reported that the County Social Services mental health re-

gion has disbanded and there is now one statewide agency. The existing CSS 28E will be terminated; CSS region will remain open until June 30, 2026 to finish up financial duties. Notice of Withdrawal from 28E agreement was presented – meetings will continue and county still has a vote if anything comes up between now and June 30, 2026. 25.254-Motion Clark/Second Keatley to approve the Notice of Withdrawal from County Social Services 28E Agreement. Motion

25.255-Motion Keatley/Second Clark to set the Public Hearing for 3 amendments to Zoning Ordinance L for Monday, July 28 at 9:10 am. Motion carried.

Byrnes presented an easement agreement for approval. 25.256-Motion Clark/Second Keatley to approve Real Estate Easement Agreement as presented. Mo-

tion carried. 25.257-Motion Keatley/Second Clark to approve liquor license renewal for Sportsmans Club. Motion

25.258-Motion Clark/Second Keatley to accept and place on file quarterly reports for Auditor and Sheriff. Motion carried.

Engineer Ridenour asked approval of contract and bond from Midwest Contractors Inc. 25.xxx-Motion Clark/Second Keat-

ley to approve contract and bond from Midwest Contractors Inc. for concrete pavement patching at \$141,994.31. Motion carried.

Department Head Updates: Engineer Ridenour gave road project updates including getting LP quotes for consideration next Monday; finishing an update to the safety action plan required for future federal funding. Auditor Beyer provided tax statement process update.

The Owner may, at their discretion, reject any or all bids, waive informalities, irregularities or technicalities, or accept the bid and award the Project.

The successful bidder will be required to furnish bonds and insurance, in accordance with Article 6 of the Contract, when the Contract is delivered to the Owner.

By virtue of the statutory authority, a preference will be given to products and provisions grown and produced within the State of Iowa and to Iowa

domestic labor. In accordance with lowa statues, a resident bidder shall be allowed a preference as against a nonresident bidder from a state or foreign country if that state or foreign country gives or requires any preference to bidders from that state or foreign country, including but not limited to any preference to bidders, the imposition of any type of labor force preference, or any other form of preferential treatment to bidders or laborers from that state or foreign country. The preference shall be equal to

the preference given or required by the state or foreign country in which the nonresident bidder is a resident. In the instance of a resident labor force preference, a nonresident bidder shall apply the same resident labor force preference to a public improvement in this state as would be required in the construction of a public improvement by the state or foreign country in which the nonresident hidder is a resident
