Board members present: Byrnes, Reiser and Schellhammer. All members voting "AYE" unless noted.

Meeting called to order by Schellhammer, followed by the Pledge of Allegiance.

22.290-Motion Byrnes/Second Reiser to approve today's agenda and minutes from July 25 2022. Motion carried.

The following people were present at various times throughout the meeting in person: Joe Moses-Waukon Standard, Denise Beyer - Auditor and Clerk to Supervisors, Michael Coyle, Jack Knight, Dennis Blocker, Sandy Lloyd, Clark Mellick, Tony Gericke, Val Reinke, Laurie Moody, Stephanie Runkle, Brian Ridenour, Mike Hohenbrink - Postville Herald, Corey Snitker.

Public Comment: Michael Coyle reviewed new hires, new clinic opening in Postville, and gave an update on the progress of the mental health clinic. Coyle also mentioned the upcoming community forums regarding hospital updates and the public measure that will be on the November 8 ballot. Jack Knight complimented road department on the new Smithfield bridge. Val Reinke reviewed RAGBRAI and upcoming Corn Days events. Schellhammer thanked all the volunteers in the county for a successful RAGBRAI.

22.291-Motion Reiser/Second Byrnes to open public hearing regarding repeal of ATV/UTV ordinance. Motion carried.

Attorney Tony Gericke commented that the ordinance is no longer valid due to recent legislation. Mellick said money from citations will go to the state. Ridenour commented that though special events permits will not be required, it is best to notify the county of special rides.

22.292-Motion Byrnes/Second Reiser to close public hearing regarding repeal of ATV/UTV Ordinance. Motion carried.

22.293-Motion Byrnes/Second Reiser to repeal ATV/UTV Ordinance dated 7.3.17 as said ordinance has been preempted by state law. Motion carried.

22.294-Motion Byrnes/Second Reiser to accept and place on file Manure Management Plans/updates for Long View Ridge, Dennis Gruber, Gruber Ridge LLC, Wayne & Shelly Weber Farm and Millerway. Motion carried.

22.295- Motion Reiser/Second Byrnes to accept and place on file

quarterly report for Environmental Health. Motion carried.

22.296-Motion Byrnes/Second Reiser to approve use of county credit card for purchase/replacement of Meeting Owl for Board of Supervisors room not to exceed \$1,200. Motion carried.

Updated credit card policy presented with previously discussed changes.

22.297-Motion Reiser/Second Byrnes to update credit card policy effective 8/1/22. Motion carried.

Stephanie Runkle presented the proposed zoning ordinance amendment and asked Supervisors to set a public hearing.

22.298-Motion Byrnes/Second Reiser to set public hearing date for August 15, 2022 at 9:40 a.m. for amendment #10 to Zoning Ordinance L. Motion carried.

Engineer Ridenour presented resolution, including one objection, to vacate portions of 4 county secondary roads listed in Resolution.

22.299-Motion Reiser/Second Byrnes to approve resolution to permanently close/vacate portions of four old public Secondary Roads. Roll call: Reiser-aye; Byrnes-aye; Schellhammer-aye. Motion carried. (Full text of resolution available in Auditor's office)

Engineer Ridenour has contacted NRCS to see if they have any comments regarding re-bidding the project and extending the agreement into next year, and possibly a dollar increase in the agreement.

The only bid was about 47% over the NRCS Engineer's estimate. NRCS concurs that rejecting the bid and extending the agreement is the best course of action.

22.300-Motion Reiser/Second Byrnes to reject all bids for repair of English Bench site #9. Motion carried.

Department Head updates: Sheriff Mellick gave RAGBRAI and department update. Corey Snitker, Emergency Management Director, reviewed RAGBRAI, weather and upcoming events. Engineer Ridenour reviewed upcoming 6-county meeting on Thursday this week, followed up on process for closing/vacating roads and gave department update. Auditor Beyer updated on tax statement process, the IBAT proclamation and Opioid settlement.
