1. A special meeting of the City Council of Postville, Iowa, was held in the Council Chambers at 147 N. Lawler St. on January 20, 2025, beginning at 6:00 p.m. with Mayor Pro-tempore Mary Engstrom presiding.
2. On call of the roll, the following Council Members were present, Larry Moore, Laurie Moody, Mary Engstrom and Becky Engelhardt. Absent: Devora Klein-Mahr. The pledge of allegiance was recited by those in attendance.
3. Council Member Moody approved the agenda as posted by the Clerk. Seconded by Engelhardt. Carried.
4. A budget work session was held. The Council discussed allocating funding to the following boards and organization from the budget FY 25/26: Northeast Iowa Wellness Center-\$5,000; Postville Library Board-\$56,000; Postville Ambulance-\$9,600; Postville Swimming Pool Board-\$40,000; NEICAC-\$2,000; Allamakee County Economic Development-\$5,000; Clayton County Economic Development-\$400; NE Iowa Housing Trust Fund-\$2,000; Postville Child Care- \$5,000; Postville Fire Department- \$32,500. The Council will review the final budget on February 10, 2025, and set the public hearing. Discussion was held on expenditures for all city departments. There being no further business on the agenda to come before the Council, Council Member Engelhardt made a motion that the meeting be adjourned. The motion was seconded by Moody. Carried unanimously.
