followed by Pledge of Allegiance. 25.193-Motion Keatley/Second Clark to approve today's agenda and minutes from May 19 and 21, 2025 meeting. Motion carried.

The following people were present at various times throughout the meeting in person or via Zoom: Joseph Moses - Standard newspaper, Denise Beyer - Auditor/Clerk to Supervisors, Roger Erickson, Jon Luchsinger, Carrie Everman, Janel Eglseder, Brian Ridenour, Roger Mohn, Destiny Kapler-Postville Herald, Clark Mellick.

Public Comment: Roger Erickson asked about pioneer cemeteries because he mows the Village Creek Cemetery and there is a big tree that needs to come down before it damages some stones. Carrie Everman called in to express concern about an issue and Supervisor Byrnes agreed to get back to her within 2 days.

Jon Luchsinger provided a contract for ESI for new phone system, partnering with Northeast lowa Telephone, that the committee has approved. One time \$540 charge and \$914/month for 5 years. 25.194-Motion Clark /Second Keat-

ley to approve phone contract with ESI for one time \$540 charge and \$914/month for 5 years. Motion carried.

Janel Eglseder informed Supervisors Midwest Group Benefits has offered to handle processing of Cobra insurance paperwork at no cost to County but there would be a 2% charge to the employee. An effective date of July 1, 2025 was determined.
