NOTICE OF PUBLIC HEARINGS

**Notice of Public Hearings**  
The **Planning and Zoning Commission** is considering a request, filed by landowners Randy, Dennis, and Donald Troendle, for an amendment to the Allamakee County Zoning Ordinance and Map. The amendment will change the zoning district of a portion of a parcel from A-1 Agricultural to R-1 Rural Residential District. The parcel is legally described as SW EX PT S OF RD & EX LOT 1 SW SW & EX LOT 1 NE SW; SW SE LYING N OF RD; NW SE EX PT LOTS 13 & 15 OF CREEK VIEW SUBDIV & EX LOT 1; PAR IN NW COR OF SE SE; NE SE LYING S OF HWY 9 EX LOT K, Sec 25, Township 95 North, R4W, Parcel ID: 0725451001. This zoning change will allow the Troendes to develop a portion of their property to be developed into (6) 3-acre parcels to sell for residential development.
