MINUTES OF THE ALLAMAKEE COUNTY BOARD OF SUPERVISORS MONDAY, DECEMBER 4, 2023 (UNOFFICIAL)

Board members present: Reiser and Keatley. Byrnes absent. All members voting "AYE" unless noted.

Meeting called to order by Reiser, followed by the Pledge of Allegiance.

23.424-Motion Keatley/Second Reiser to approve today's agenda and the minutes from November 27, 2023. Motion carried.

Runkle presented plats for approval.

Runkle presented two amendments to the Zoning Ordinance L, both were named #3. Runkle recommended to renumber the Amendment #3 passed in April

2016 as 3.1 and the one passed in December 2019 as 3.2 because both were passed and are valid.

23.428-Motion Keatley/Second Reiser to renumber Amendment 3 passed on April 18, 2016 to Amendment 3.1 and renumber Amendment #3 passed on December 30, 2019 to Amendment 3.2 to the Zoning Ordinance L. Motion carried.

Corey Snitker informed Supervisors the draft Courthouse Public Building Safety Plan is ready for approval. Supervisors agreed to place this on December 18 agenda at the end of the meeting, with possible closed session for confidentiality of safety protocol. Following approval of the plan, Snitker will begin training county employees on the plan and put a plan in place for training of future new hires.

Department Head updates: Sheriff Mellick gave department update including an upcoming meeting with Roger Mohn to discuss cost estimates for the water system - Reiser will attend if able. Corey Snitker gave department and meeting updates; he is currently the Local Emergency Planning Committee (LEPC) Chair; work on Lansing bridge has begun with first lane closures. Engineer Ridenour gave department updates and reviewed the snow ordinance requirements for when the road department clears roads. Ridenour reminded Supervisors of Wednesday legislative update meeting in Elkader. Auditor Beyer gave department update including tomorrow's runoff election.
