MINUTES OF THE ALLAMAKEE COUNTY BOARD OF SUPERVISORS MONDAY, DECEMBER 18, 2023 (UNOFFICIAL)

Board members present: Byrnes, Reiser and Keatley. All members voting "AYE" unless noted. Meeting called to order by Reiser, followed by the Pledge of Allegiance.

23.437-Motion Keatley/Second Reiser to approve today's agenda and the minutes from December 11, 2023. Motion carried.

The following people were present at various times throughout the meeting via Zoom or in person: Joseph Moses – Standard newspaper, Denise Beyer – Auditor and Clerk to Supervisors, Stephanie Runkle, Jenny O'Neill, Laurie Moody, Jean Bossom.

Public Comment: None
23.438-Motion Reiser/Second Keatley to approve resolution of subdivision plat for Lloyd C. Johanningermeier, Jr.. Roll call: Reiser-aye; Keatley-aye; Byrnes-aye. Motion carried. (Full text of resolution available in Auditor's office)

Treasurer Jenny O'Neill presented the County Investment Policy for approval. This is approved every 2 years. There have been no changes since 2021.

23.439-Motion Keatley/Second Reiser to approve the County Investment Policy. Motion carried.

Auditor Beyer provided info for a virtual Township Official training and requested approval to pay from the county budget for any township officials who wish to take the training. Cost is \$35 per participant. Beyer confirmed an adequate

amount is budgeted.

23.440-Motion Reiser/Second Keatley to approve payment of Township Official training from county budget not to exceed \$2,520. Motion carried.

Laurie Moody requested use of county credit card for a conference hotel.

23.441-Motion Keatley/Second Reiser to approve Environmental Health use of county credit card for annual conference hotel stay for Laurie Moody and Mandy O'Neill up to \$543. Motion carried.

23.442-Motion Reiser/Second Keatley to set date for Local Option Sales Tax election as March 5, 2024. Motion carried.

Attorney Gericke discussed an option for use of Opioid Settlement Fund: Gericke and Jean Bossom have talked to 3 local police chiefs and Gericke requested \$4,500 total from Opioid Settlement Fund to give \$1,500 per police department for opioid programming in conjunction with the DARE program. Police departments will provide expenses to Jean Bossom and she will process the claim. Approval was sought to designate \$4,500 of existing Opioid funds for 2024 to be distributed evenly between Lansing, Waukon and Postville PD for these programs to enhance existing DARE programs.

23.443-Motion Keatley/Second Reiser to approve \$4,500 for 2024 programming for Lansing, Waukon and Postville PDs to enhance existing substance abuse prevention programs. Motion carried.

Department Head updates: Corey Snitker gave department update. Laurie Moody asked about vehicle

maintenance expenses and will put on a future agenda. Sheriff Mellick gave department update regarding trial last week and reported a fatality last week. Attorney Gericke gave trial update and update on documents for transfer of Veterans Memorial Hospital to county. Auditor Beyer gave department update regarding valuations and budget work session scheduling.

23.444-Motion Reiser/Second Keatley to go into closed session pursuant to Iowa Code §21.5(1)(g) and (k) regarding county building security and other security matters. Roll call: Reiser-aye; Byrnes-aye; Keatley-aye. Motion carried.

23.445-Motion Reiser/Second Keatley to exit closed session pursuant to Iowa Code §21.5(1)(g) and (k) regarding county building security and other security matters. Roll call: Reiser-aye; Byrnes-aye; Keatley-aye. Motion carried.

Discussion was held regarding the comprehensiveness of the security plan and the ease to change. Checklists as part of a training plan will be a separate document.
